

RULES OF THE GAME MAMIE CLAFOUTIS "CHRISTMAS GAME"

Article 1: Organizing Company

The Organizing Company "Mamie Clafoutis", having its head office at 2740 Rue Angus, H2H 1P3 Montréal, organizes from 12/01/2023 to 12/22/2023 midnight (Quebec date and time of the connection being authentic) or (store hours being faith) in Quebec, a game with no obligation to purchase entitled "Christmas Game".

Article 2: Participants

The Game is reserved for all adult individuals residing in Quebec, with the exclusion of any person (and in particular the staff of the Organizing Company) having participated in the design of the Game and ensuring its implementation, as well as members of their family in direct line. Participation in the Game is limited to one participation per person (same name, first name, same email address and telephone number). No one may participate in the Game on behalf of another person. The Organizing Company reserves the right to shorten, extend, postpone, modify or cancel the Game as well as to cancel or postpone the date of the draw in the event of force majeure or events beyond its control. will. In any event, it cannot be held liable and no compensation can be claimed from it in this respect. The Organizing Company reserves the right to cancel the participations of anyone who has registered several times under different identities or who has provided inaccurate information.

Article 8: Fraud
