

## **RULES OF THE GAME MAMIE CLAFOUTIS “TRY, ANSWER, WIN”**

### **Article 1: Organizing Company**

The Organizing Company “Mamie Clafoutis”, having its head office at 2740 Rue Angus, H2H 1P3 Montréal, organizes from 01/10/2024 (10 of January 2024) to 02/29/2024 (29 of February 2024) midnight (Quebec date and time of the connection being authentic) or (store hours being faith) in Quebec, a game with no obligation to purchase entitled “**TRY, ANSWER, WIN**”.

### **Article 2: Participants**

The Game is reserved for all adult individuals residing in Quebec, with the exclusion of any person (and in particular the staff of the Organizing Company) having participated in the design of the Game and ensuring its implementation, as well as members of their family in direct line. Participation in the Game is limited to one participation per person (same name, first name, same email address and telephone number). No one may participate in the Game on behalf of another person. Any person who does not meet the conditions for participation in the Game will be excluded from the Game without being able to claim the benefit of the prize at stake.

### **Article 3: Duration**

The Game will take place from 01/10/2024 (10 of January 2024) to 02/29/2024 (29 of February 2024) midnight (Quebec date and time of the connection being authentic). The Organizing Company reserves the right to shorten, extend, postpone, modify or cancel the Game as well as to cancel or postpone the date of the draw in the event of force majeure or events beyond its control. will. In any event, it cannot be held liable and no compensation can be claimed from it in this respect. **Article 7: Validity of participation**

Entries received after the deadline for participation in the Game will not be taken into consideration. Any Participant is prohibited from participating under several nicknames, with several email addresses or on behalf of other people. The Organizing Company reserves the right to cancel the participations of anyone who has registered several times under different identities or who has provided inaccurate information.

**Article 8: Fraud**

In order to safeguard the same chances for all Participants in the Game, the Organizing Company reserves the right not to award prizes to fraudsters and/or to prosecute the perpetrators of this fraud before the competent courts. The Organizing Company may cancel all or part of the Game if it appears that fraud has occurred in any form whatsoever, particularly in IT matters.

**Article 9: Exchange of the lot**

The prizes offered cannot give rise to any dispute of any kind, nor to their exchange or replacement for any reason whatsoever. The photographs or graphic representations representing the prizes at stake on the media relaying the Game are communicated for illustration purposes only and can in no way be considered contractual.
